- to encourage the creation of businesses and promote employment,

With a budget of **1 million euros**, the fund enables promoters of small innovative projects to undertake feasibility studies for their partnership project from various points of view: technical/financial/legal/commercial/managerial. Each project is allocated a subsidy of 20,000 euros max to finance up to 50% of the total costs involved in the works.

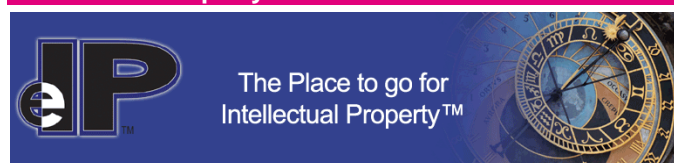

"Quick-Snake" distinguished by the "Prix Prevention" from Swiss Real Estate Insurance". If the sand bags, in the case of erosion are considered the quickest solution, the modular barrier were each modular unity corresponds to 70 sand bags could represent a more efficient solution. Anyway plausible were that this system, thought to erect sand-barriers (also submerged) to combat flood-and erosion damages, by means of a modular and mechanical driven filling method, as well could serve to create larger spaces of safety around other civil strategic objectives.

We have experimented with success in Switzerland this barrier-set up system, in company with a team of armed forces specialist on the field of disaster management, as well on a air field.

Call: FP7-SST-CIVITAS-2011-MOVE, Topic: SST.2011.3.4-1.Design, implement & test innovative strategies for sustainable urban transport.

Zalau is located in the Nord-Western part of Romania, with a surface of 90,09 km² and around 64,000 inhabitants. The transport system is formed by roads and railway (only for external relations). In order to improve the mobility we designed and started to construct a beltway/ring road for transit traffic, the first stage being finished. Also we are in the stage of contracting with EU funds an Intelligent Traffic Management System project, but this projects doesn't cover the public transport or the cycling system. The public transport fleet consist in 46 buses,7 main routes, 2 secondary routes. At the city level there are some unsolved issues regarding the mobility, noise, air pollution.

The main purpose of the project:

a) the design of a sustainable urban transport strategy/plan, specific to the local conditions in order to improve the accesibility, mobility and pollution reduction, including:

- acces restrictions policies specialy in the city centre;
- promoting and improving the public transport system, acording with the public needs: optimisation of transport route, transport capacity,transport programs, time efficiency, aproprate infomobility tools;
- policy options for freight distribution;
- policy for trafic transit;
- city cycle and walking routes;

b) the implementation of some elements of this plan, such us: clean and energy efficient busses for public transport, intelligent public local transport and walking management system (to be integrated in the existing ITS project), introducing new and modern way to inform and communicate with the clients of the public transporatation system (digital panels with real time information in the most important stations,etc), e-ticketing, access restrictions policies (including a pedestrian area in the city centre), video surveillance cameras in buses, other measures to promote and improve public transport and cycling, etc.
